



Clues

- 1. Only one student was suspended.
- 2. The number of people at band practice was one less than the number at football practice.
- 3. The number of students at play practice was two less than the number of students with no alibis and one less than the number of cheerleaders.
- 4. There were twice as many football players as there were cheerleaders.
- 5. Twice as many people were at play practice as were suspended.




Suspects' Names and Grades

The four suspects who did not have alibis for the afternoon of the crime were Molly, Otis, Norman, and Samantha. Their last names are Mitchell, Oswald, Nelson and Snodgrass. None of the first names begin with the same letter as the last names. Each suspect received either a C, D, D-, or F on his or her term paper. Solve the logic puzzle to find out the last names of each suspect and what grade they received.

Clues

- 1. The suspect whose last name is Nelson received a C on the paper.
- 2. Neither Otis or the student who received a D- have last names beginning with M or N.
- 3. Molly was upset when she received the second to the lowest grade.



Time Clues

Each of the suspects rode a school bus on the afternoon of the crime and got home at different times. They arrived at 3:10 p.m., 3:15 p.m., 3:25 p.m. and 3:30 p.m. None of the students' parents were at home when they arrived. No one saw the suspects until after 5:00 p.m. that evening. The suspects live in neighborhoods not far from the mall. It takes no more than 10, 15, 20, or 30 minutes to walk to the mall from their homes. Solve the logic puzzle to find out what time each suspect arrived home and how long it would take him or her to walk to the mall.

Clues

- 1. The suspect who arrived home at 3:10 p.m. could walk to the mall in 30 minutes.
- 2. Neither Samantha or the student who could walk to the mall in 10 minutes arrived home before 3:20 p.m.
- 3. Molly arrived home at 3:30 p.m.
- 4. Otis and the suspect who needed 15 minutes to walk to the mall were friends.
- 5. It took Norman 20 minutes to walk to the mall.



- 4. Now, solve the puzzle, "Suspects Names and Grades".

 Remember you are building on the information from the previous puzzle.
- 5. Solve, "Time Clues" to build even further on your evidence.
- 6. Complete the puzzle, "Descriptions of the Suspects"
- 7. Finally, complete the puzzle, "Clothing Worn by the Suspects"
- 8. Look at the Blue and Yellow portions of the map, lining up the two sides to create one big map! Now, mark the following locations using the clues:
 - a. A yellow jacket was found in the dressing room in the So Comfy Clothing Store.
 - b. Two sections of a large chocolate chip cookie were found in the Have Fun Toy Store. One piece was found in the bin with the beach balls. The other had been kicked beneath a shelf containing baby toys.

- 10. See if you can reconstruct the crime on your maps of the mall.


Witnesses' Statements

Witnesses who claimed to have seen a teenager running in the mall or acting suspiciously were questioned by the mall security. Some of the witnesses were found to be reliable. The statements made by others, however, conflicted with the facts known about the possible suspects.

The witnesses were asked if they had noticed a young person in the mall with a giant cookie or one who was acting suspiciously. They were then asked where they saw the person, what the person was wearing, height.

Read the statements made by each witness. Look for patterns in the statements. For example, did more than one of the witnesses see the same thing? Which statements seem to be relevant? Which do not seem to apply to the crime?



Witness 1

"A young person was in the book store, The Great Books Book Store. He looked suspicious to me, because he was looking through cookbooks. He was wearing a red shirt and red plaid pants. I didn't notice a jacket or anything. He had dark hair; I'm not sure whether it was brown or black. He was average height."

Witness 2

"I was standing in front of the Bridal Shop, waiting for my friend. I saw a boy, a teenager, head straight toward the south entrance. He seemed to be in a hurry, but when he reached the door, he spun around and hurried back down the hallway towards the main part of the mall. I couldn't figure it out until I saw the security guard standing outside the door. That's when I asked the guard if something had happened. The boy was wearing a brown shirt and blue jeans. He was tall, at least 5'9" and skinny, very skinny. I think he had brown hair. He was carrying one of those yellow bags from So Comfy Clothing Store."

Witness 3

"A boy wearing a bright yellow jacket ran past me. I was standing by the fountain in front of the Great Buy Department Store. The boy was carrying the largest cookie I have ever seen. He ran into the toy shop. He was tall with brown hair and lanky; not much meat on his body."

Witness 4

"There was a boy in the gift shop wearing a yellow shirt. He was just looking around, not buying anything. He was tall and heavy, like he had eaten way too many biscuits. He had brown hair. He was not carrying a package or anything."

Witness 5

"When I was waiting to pay for my new sunglasses at the small booth, I noticed a boy running in front of the candy store. He darted into So Comfy Clothing Store. He was wearing a yellow jacket and blue jeans, I think. He had brown hair and was tall, at least 5'9". He was not carrying anything."

Witness 6

"I was shopping in the men's department in the Great Buy Department Store when I noticed a young teenage boy in a yellow jacket looking for shirts. He was short, only about 5'1"or so. He had brown hair. He was carrying a package from Jeans'N Wear."

Witness 7

"I had been looking at Indian jewelry at that booth in the middle of the mall when I saw a teenage girl run into the Fancy Men and Women's Clothing Shop. She acted like she was being chased or something. I looked but saw no one following her. She had on a red shirt. She was tall, like a model, and had incredible hair, blonde and very long.

Witness 8

A young boy almost knocked me down when I was coming out of the Sports Center. He raced past me through the door. He didn't even say 'Excuse Me.' I got a good look at him. He was tall, very thin, and had brown hair. He was wearing a brown shirt and blue jeans. I noticed he had a package from my favorite store, So Comfy Clothing Store."

Witness 9

"I was sitting in front of the Spend More Department Store. I saw a kid walk by wearing a black baseball cap from the Baltimore Orioles. I said something to him as he passed, like 'Good Team,' but he didn't even look up. I was certain he heard me. I figured he didn't want to be bothered with an old man. He was heading down the mall toward the southeast entrance. He was about as tall as my son, 5'10' or so, and skinny like my boy too. His hair was brown. The boy had on a brown shirt and blue jeans and was carrying a package. I think it was yellow.

Witness 10

"I saw a boy coming out of the pet store. He was carrying what I guess was fish in a white container. He also had a yellow bag. I followed him out of the mall, out the southeast entrance.
